

OFFICIAL RULES FOR THE GOLDEN TICKET RAFFLE TO BENEFIT ASHEVILLE CATHOLIC SCHOOL

1. Please Read the Complete Official Rules: The following are the Official Rules for The Golden Ticket Raffle (“Raffle”). By participating, contestants agree to be bound by these Rules and that all decisions of Asheville Catholic School (“School”) on all matters relating to this Raffle are final. Failure to meet all requirements of the Rules may disqualify the winner from receiving the Prize.

2. How to Enter: Contestants may purchase tickets for the Raffle: (a) in person through a student currently enrolled at the School, (b) online at the dedicated event website, or (c) on site at the 2010 Spring Fling Gala for Education. Tickets must be filled out completely with name, address, city, state, zip code, and phone number. Student and online ticket sales close at 11:59 p.m. on 4/22/2010. Ticket sales on site at the 2010 Spring Fling Gala for Education will close at such time as is determined by the auctioneer during the event on 4/26/2010. Any form of entry other than the ones described herein are void.

3. Eligibility: Contestants must be at least 18 years of age. Employees of Asheville Catholic School and their immediate families are not eligible. Anyone who attempts to defraud or in any way tamper with the Raffle will be deemed ineligible. All federal, state, and local laws and regulations apply. Void where prohibited or restricted by law. Odds of winning depend upon the number of entries received.

4. Prize: The winner of the Golden Ticket Raffle may designate one (1) student as the recipient of the Prize of paid tuition expense at Asheville Catholic School for the 2010 – 2011 school year. To qualify for the prize, the designated student must be registered to attend Asheville Catholic School for the 2010-11 school year. The Prize is not redeemable for cash.

5. Selection of Winner: The winner will be selected from all eligible tickets received in a random drawing conducted during the Spring Fling Gala on or about April 26, 2010. Reasonable efforts will be made to contact any winner not present at the Spring Fling Gala by telephone and mail. An alternate winner may be selected within ten (10) days of notification if the original winner does not claim the Prize or if the Prize is not accepted as offered. Federal, state and local taxes (income or otherwise) are the sole responsibility of the winner. The winner must sign a standard release form providing their address, telephone number, social security number and a W-9 tax form.

6. General Terms and Conditions: Ticket price for this Raffle is Fifty Dollars (\$50.00) per ticket. By entering, participating or accepting the Golden Ticket Raffle Prize, you agree that Asheville Catholic School has the sole right to decide all matters and disputes arising from this Raffle. All contestants release the School, Sponsor, and their respective directors, trustees, officers, employees, agents and affiliates, along with any other acting on behalf, from any and all claims, liability, loss or damage including, without limitation, any personal injury (including death) or damage to property and any third party claims, arising from or relating to, directly or indirectly, in whole or in part, this Raffle, including entry and participation in this Raffle and acceptance, possession, use or misuse of the Prize, whether under theory of contract, tort (including negligence and/or fraud) warranty or other theory. You further agree that in the event of any third party claims, damages, losses or injuries, arising from or relating to this Raffle arising from your entry, participation or acceptance of any prize, you indemnify the School, Sponsor, and their directors, trustees, officers, employees and agents from any and all such claims, including reasonable attorneys’ fees related thereto.
